Call for Proposals

The NYSPA Conference Planning Committee invites proposals for plenary and workshop sessions, as well as abstracts for poster presentations for the 2023 conference. You are invited to submit a proposal for a plenary session (offering 5-7/1-1.25 hr. sessions, including Q & A), workshop (offering 8-12/1-hour workshops, including Q & A), and/or a poster display (posters will be displayed throughout the Conference – see guidelines below).

Process: Complete the Conference Proposal Application Form found at the end of this document. Proposals should be sent to: nyspa@nysperinatal.org.

Theme subcategories: The goal for this two-day conference is to present the latest clinical research, policies, best practices, and evidence-based programs impacting maternal-infant-child health (MICH).

Suggested “hot topics” include (we also welcome proposals for additional topics related to the conference theme):

- A. Burnout in Families and Care Providers
- B. Maternal Mental Health and Wellness
- C. Evidence-based Research in MICH
- D. Current Hospital and Clinical Practices
- E. Cultural Humility Training for Providers
- F. Birthing Partner’s Perspective
- G. Pediatric Illness and Mortality
- H. Childbirth and the Law; Reproductive Justice and “Birth Rights”

All accepted plenary sessions and workshops will be submitted for Continuing Education Credit (CNE and CME) approval. Submissions and supporting documentation MUST be completed by all speakers/presenters by the deadlines listed below.

Poster guidelines: Posters must be peer-reviewed. There are two tracks:

1. Research & Clinical Practice
2. Successful programs and best practices in Public, Community, Maternal, and/or Infant and Child Health.

Submission Timeline/Deadline:

Plenary & Workshop sessions: The committee will begin reviewing proposals in November 2022 and will continue doing so until the agenda is complete. Our goal is to complete the competitive review process and select all sessions no later than 3/17/23.

Poster abstracts can be submitted anytime between 11/01/2023 and 4/28/2023. Posters should be clearly identified as to which track they should be considered for. Abstracts will be peer reviewed for acceptance.

Acknowledgement & Notification:

All submissions will be acknowledged within 48 hours to confirm receipt and completeness.

Plenary and Workshop Proposals will be reviewed on submission. Decisions will be made on a rolling bases within 30 days of receipt at which time the presenters will be notified. Selection decisions will be made until the agenda is complete and no later than 3/17/23.

Presenters **MUST** complete and return an acceptance agreement (including continuing education documentation) within ten days of acceptance notification. Any selected session for which the presenter does not complete the acceptance agreement will be withdrawn from the program and replaced with an alternative presentation and speaker.

Poster Abstracts will be reviewed on a rolling basis and no later than 4/14/23, with authors notified by 4/30/23. Poster authors **MUST** complete and return an acceptance agreement no later than 5/12/23 with a non-refundable reservation fee of \$25. The \$25 fee is to cover the cost of the board rental. The authors of accepted posters will be provided a 25% discount on the conference registration fee. Any poster for which the author does not complete the acceptance agreement and submit the \$25 fee by 5/12/23 will be withdrawn from the program.
